

A telegraph company which has a continuous line between points in the same state over which it might transmit a message received for that purpose, but which passes through another state on the route, cannot claim that the message is interstate commerce and therefore exempt from state authority limiting the charge for transmission, although the company does not in fact transmit the message the whole distance, but delivers it at an intermediate point in another state to another company because its own line for the remainder of the distance is fully occupied by other business. Decided April P3, 1895.
